to repeal the Assam Darrang and Lakhimpur Districts (Assimilation of Laws on State Subjects) Act, 1951.

Preamble

Whereas it is expedient to repeal the Assam Darrang and Lakhimpur Districts (Assimilation of Laws on State Subjects) Act, 1951;

Assam Act No. XV of 1951

It is hereby enacted in the Seventy-third Year of the Republic of India as follows:-

- 1. (1) This Act may be called the Assam Darrang and Lakhimpur Districts (Assimilation of Laws on State Subjects) (Repealing) Act, 2022.
 - (2) It extends to the whole of the State of Assam.
 - (3) It shall come into force at once.

(1) The Assam Darrang and Lakhimpur Districts (Assimilation of Laws on State Subjects) Act, 1951 is hereby repealed.

(2) Notwithstanding such repeal under section 2, the validity or effect or consequence of anything already done or suffered or any right, title, obligation or liability already acquired, accrued or incurred or any remedy or proceeding in respect of any such right, title, obligation or liability or penalty, claim or demand etc. already enforced under the Act so repealed, shall be deemed to have been validly done or taken or passed under the corresponding provisions of the Act, so repealed.
