ANDHRA PRADESH BILLS ANDHRA PRADESH LEGISLATIVE ASSEMBLY

The following Bill was introduced in the Andhra Pradesh Legislative Assembly on 21ST November, 2024.

L. A. Bill No. 26 of 2024

A BILL FURTHER TO AMEND THE ANDHRA PRADESH MUNICIPALITIES ACT, 1965 AND THE MUNICIPAL CORPORATIONS ACT, 1955.

Be it enacted by the Legislature of the State of Andhra Pradesh in the Seventy-Fifth Year of the Republic of India as follows:-

- (1). This Act may be called the Andhra Pradesh Municipal Laws Short title and commencement,
 (Second Amendment) Act, 2024.
 - (2) It shall come into force on such date, as the Government may, by notification in the Andhra Pradesh Gazette, appoint.
- In the Andhra Pradesh Municipalities Act, 1965, Section 170-B shall be omitted.

Omission of Section 170-B. Act No.VI of 1965.

In the Municipal Corporations Act, 1955, Section 491- A shall be omitted.

Omission of Section 491-A. Act No.II of 1956.

STATEMENT OF OBJECTS AND REASONS

The Government of Andhra Pradesh have made certain amendments to the Municipal Corporations Act, 1955 and to the Andhra Pradesh Municipalities Act, 1965 vide Act No. 44 of 2020, by inserting Section 491-A (Levy of user fee for Solid Waste Management) in the Municipal Corporations Act, 1955 and Section 170-B (Levy of user fee for Solid Waste Management) in the Andhra Pradesh Municipalities Act, 1965.

In this regard, the Government have issued certain guidelines for collection of User Fee for Solid Waste Management activities.

The new mechanism of collection of User Fee for Solid Waste Management commenced in 40 Urban Local Bodies from November, 2021 onwards and an amount of Rs. 187.02 Crs was collected as against User **Fee** demand of Rs.637.62 Crs up to July, 2024. The average monthly payment to the agencies amount to Rs. 13.94 Cr.

The collection of user fee is being perceived as a burden by the common man. Therefore, the Government have decided to dispense the collection of user fee for solid waste management.

In order to issue directions under Section 387-A of the Andhra Pradesh Municipalities Act, 1965 and Section 679-E of the Municipal Corporation Act 1955 for not collecting the user fee, it is essential to delete the provisions related to levy and collection of user fee for Solid Waste Management i.e., Section 491- A of Municipal Corporation Act 1955 and Section 170-B of AP Municipalities Act, 1965. So that the directions don't become inconsistent with the provisions of the Acts. Therefore it is decided to amend the said Acts suitably.

The bill seeks to give effect to the above decision.

MEMORANDUM REGARDING DELEGATED LEGILSTAION

The above provisions of the Bill regarding delegated legislation are thus of a normal type and mainly intended to cover matters of procedure.
