THE MADHYA PRADESH VISHWAVIDYALAYA (SANSHODHAN) VIDHEYAK, 2022
A Bill Further to amend the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973.

Be it enacted by the Madhya Pradesh Legislature in the seventy-third year of the Republic of India as follows :—

Short title and commencement.

1. (1) This Act may be called the Madhya Pradesh Vishwavidyalaya (Sanshodhan) Adhiniyam, 2022.

(2) It shall come into force from the date of its publication in the Madhya Pradesh Gazette.

Amendment of Second Schedule.

2. In the Second Schedule to the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 22 of 1973),—

(i) in Part I, for serial number 6 and entries relating thereto, the following serial number and entries relating thereto shall be substituted, namely:—

"6.	Barkatullah Vishwavidyalaya, Bhopal	Bhopal	Bhopal, Sehore, Raisen, Vidisha, Hoshangabad, Rajgarh, Harda and Betul.";

(ii) in Part II, for serial numbers 2 and entries relating thereto, the following serial number and entries relating thereto shall be substituted, namely:—

"2.	Raja Shankar Shah University, Chhindwara.	Chhindwara.	Chhindwara, Seoni and Balaghat ".

STATEMENT OF OBJECTS AND REASONS

In the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 23 of 1973), the territorial jurisdiction of Raja Shankar Shah Vishwavidyalaya, Chhindwara includes Seoni, Balaghat and Chhindwara of Jabalpur division and one district Betul of Narmadapuram division, The remaining districts Hoshangabad and Harda of Narmadapuram division are included in the territorial jurisdiction of Barkatullah Vishwavidyalaya, Bhopal. In view of ease of transportation and administrative convenience, it is proposed to re-incorporate Betul district in Barkatullah University, Bhopal. Therefore, suitable amendments are proposed in the Madhya Pradesh Vishwavidyalaya Adhiniyam, 1973 (No. 23 of 1973).

2. Hence this Bill.
