MAHARASHTRA ORDINANCE No. II OF 2010.

AN ORDINANCE

further to amend the Maharashtra Value Added Tax Act, 2002.

WHEREAS both Houses of the State Legislature are not in session ;

AND WHEREAS the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take Mah. immediate action further to amend the Maharashtra Value Added ^{IX of} Tax Act. 2002, for the purposes hereinafter appearing;

STATEMENT

Sub-section (I) of section 9 of the Maharashtra Value Added Tax Act, 2002 (Mab. IX of 2005) provides that, the State Government may, by notification in the Official Gazette, provide for reducing or enhancing the rates of tax specified in the Schedules appended to the said Act. The proviso to the said sub-section (1) provides that, no notification which provides for enhancement of rate of tax shall be issued after the expiry of the period of two years from the appointed day and not more than one such notification shall be issued within such period. Sub-section (2) of section 9 of the said Act provides that, any notification issued under subsection (1) shall be laid before the State Legislature on par with the rules made under section 83 by the State Government. The said period of two years from the appointed day, i.e. from the 1st April 2005, has already been expired on the 31st March 2007. With a view to meet certain contingencies, it is proposed to delete the proviso to sub-section (1) of section 9 of the said Act, so as to enable the State Government to enhance the rates of tax by notification under the said sub-section (1). However, the power of the State Government to issue any such notification under sub-section (I) shall be subject to the provisions of sub-section (2) of section 9 of the said Act.

2. As both Houses of the State Legislature are not in session and the Governor of Maharashtra is satisfied that circumstances exist which render it necessary for him to take immediate action further to amend the Maharashtra Value Added Tax Act, 2002, for the purposes aforesaid, this Ordinance is promulgated.
