OFFICE ORDER


SOP FOR SCREENING OF THE STRANDED PERSONS MOVING OUT OF/INTO  
DELHI FROM/TO OTHER STATES

Delhi Disaster Management Authority wide Order No. F.2/07.2020/S.I./129 dated 03.05.2020 has issued SOP for movement of stranded persons from and into NCT of Delhi, wherein Health and Family Welfare Department has been directed to make arrangements for proper screening of such stranded persons who are moving out of/into Delhi to/from other States.

In this regard, the following SOP is being issued:-

1. The CDMOs shall appoint a Nodal Officer for the District who shall be in constant Liaison with the District Nodal Officer (ADM Concerned) to ensure that every person moving out of/into Delhi is a screened before being permitted to proceed further.
2. District CDMOs shall constitute dedicated teams consisting of One Doctor, One Nurse, One NO and One Pharmacist in each team for screening of the persons. The team shall be provided with all necessary medical equipments i.e.appropriate PPE, Thermal gun etc. to ensure proper screening.
3. The number of teams shall depend upon the number of persons to be screened/location of embarkment/disembarkment and shall be fixed in consultation with the District Nodal Officer (ADM) concerned.
4. The persons found asymptomatic shall be allowed to move out of Delhi as per the SOP of DDMA, Delhi. Similarly, the persons coming into Delhi shall be allowed to go their respective home after ascertaining that they are asymptomatic. Further they would be requested to download AAROGYA SETU APP on their mobiles, if possible.
5. The persons who are found mild symptomatic shall be informed about the Self/Home Quarantine protocol and shall be directed to undergo 14 days Self/Home Quarantine. Further they would be requested to download AAROGYA SETU APP on their mobiles.

6. For the persons who are found symptomatic, standard protocol for Sampling/ Testing and Quarantine SOP shall be followed by the CDMO concerned.
