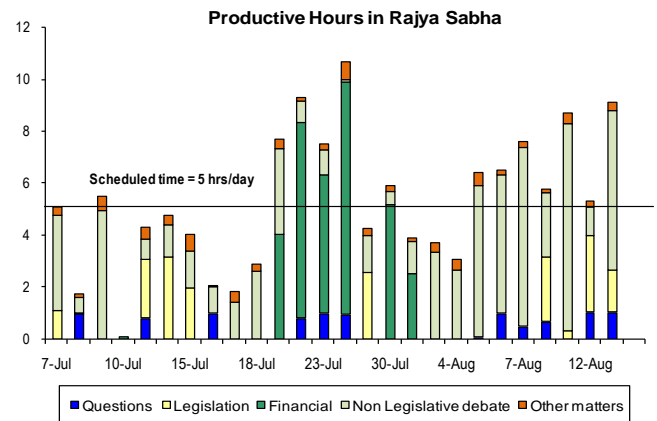
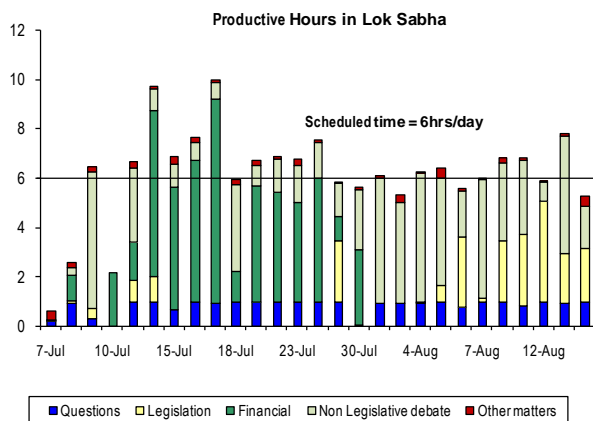


Plan vs. Performance

Budget Session – July 7 to August 14, 2014

This note lists the legislative business planned by Parliament and compares it with the actual performance during the Budget Session of the 16th Lok Sabha.

The Lok Sabha and Rajya Sabha sat late on several days to discuss the Railway, General and Delhi Budgets. Besides legislation, Lok Sabha discussed various issues related to the monsoon, inflation, spread of encephalitis, atrocities against women and children, and communal violence. Rajya Sabha discussed the working of three ministries - Women and Child, Power and Home Affairs. 20 Bills were introduced and 12 including six relating to the budget were passed. Lok Sabha worked 3% and Rajya Sabha worked 5% more than the scheduled hours.
