



Budget Session: January 31 – March 23, 2020


This note lists the legislative business planned by Parliament and compares it with the actual performance during Budget Session 2020.

The session was curtailed by seven days due to the public health emergency situation created because of COVID-19. Both Houses discussed the President's address and issues of law and order situation in multiple parts of Delhi. 17% of the central government's expenditure was discussed in Lok Sabha, and the remaining was guillotined.

In this session, 12 legislative Bills were introduced and five were passed. This excludes the Finance Bill, and the Appropriation Bills to approve expenditure out of the Consolidated Fund of India. Lok Sabha worked for 86% and Rajya Sabha worked for 74% of their scheduled time.
