Government Bills passed by Parliament during the Budget session

Short Title	Key Objectives
The Chartered Accountants, the Cost and Works Accountants and the Company Secretaries (Amendment) Bill, 2021	Amends disciplinary mechanism for chartered accountants, cost accountants, and company secretaries.
* The Criminal Procedure (Identification) Bill, 2022	Replaces the Identification of Prisoners Act, 1920. Expands the type of identification data that may be collected, and persons whose data may be collected. It authorises the National Crime Records Bureau to collect, store, and preserve these details.
* The Delhi Municipal Corporation (Amendment) Bill, 2022	Merges the three municipal corporations under the Delhi Municipal Corporation Act, 1957 into one Corporation. Reduces the total seats in the Corporation from 272 to 250.
* The Constitution (Scheduled Tribes) Orders (Amendment) Bill, 2022	Includes the Darlong community as a sub-tribe of the Kuki tribe in the list of Scheduled Tribes in Tripura.
* The Constitution (Scheduled Castes and Scheduled Tribes) Orders (Amendment) Bill, 2022	Amends the list of Scheduled Castes and Tribes in Jharkhand.
* The Appropriation Bill, 2022	Authorises expenditure from the Consolidated Fund of India for the financial year 2022-23.
* The Appropriation (No.2) Bill, 2022	Authorises additional expenditure from the Consolidated Fund of India for the financial year 2018-19.
* The Appropriation (No.3) Bill, 2022	Authorises additional expenditure from the Consolidated Fund of India for the financial year 2021-22.
* The Finance Bill, 2022	Amends income taxes and indirect taxes for the financial year 2022-23. Also imposes taxes on crypto asset transactions.
*The Jammu and Kashmir Appropriation (No.2) Bill, 2022	Authorises expenditure from the Consolidated Fund of UT of Jammu and Kashmir for the financial year 2022-23.
* The Jammu and Kashmir Appropriation Bill, 2022	Authorises additional expenditure from the Consolidated Fund of the UT of Jammu and Kashmir for the financial year 2021-22.
