


Plan vs. Performance


Inaugural and Budget Sessions: June 24 to August 9, 2024

The Inaugural Session of Parliament was scheduled to be held from June 24, 2024 to July 3, 2024. The Budget Session was scheduled from July 22, 2024 to August 12, 2024. The Budget Session was adjourned a day earlier. Over both the sessions, Lok Sabha worked for 123% of its scheduled time and Rajya Sabha for 110% of scheduled time. Eleven Bills were introduced in the Budget Session (excluding the Appropriation and Finance Bills).
