Budget Session: January 31 to April 4, 2025

Government Bills passed by Parliament during the Budget Session

Short Title	Key Objectives
The Waqf (Amendment) Bill, 2024	Amends the Waqf Act, 1995 to allow only Muslims practising Islam for 5 years to dedicate waqf, allow non-Muslims members in the Central Waqf Council and State Waqf Boards, remove waqf-by-user, and revoke the finality of decisions of the Waqf Tribunal.
The Mussalman Wakf (Repeal) Bill, 2024	Repeals the Mussalman Wakf Act, 1923.
*The Protection of Interests in Aircraft Objects Bill, 2025	Gives legal effect to international agreements which secure rights for assets such as aircrafts, helicopters, and engines in case of default.
*The Immigration and Foreigners Bill, 2025	Empowers the central government to notify designated immigration posts for entry into and exit from India. Provides for the Bureau of Immigration, and lists the obligations of persons and entities to provide information about foreigners
*The "Tribhuvan" Sahkari University Bill, 2025	Seeks to establish the Institute of Rural Management Anand (IRMA), Gujarat as the Tribhuvan Sahkari University.
The Railways (Amendment) Bill, 2024	Repeals the Indian Railway Board Act, 1905 and incorporates the provisions of the 1905 Act into the Railways Act, 1989.
The Banking Laws (Amendment) Bill, 2024	Amends different banking laws to alter the tenure of directors of co-operative banks, increase the number of nominees for a bank deposit. Also changes the definitions of 'fortnight' in the context of cash reserves, and 'substantial interest' in a company.
The Disaster Management (Amendment) Bill, 2024	Provides for the formation of Urban Disaster Management Authorities in cities and State Disaster Response Forces at the state level, and expands the functions of National and State Disaster Management Authorities.
The Boilers Bill, 2024	Provides for regulation of boilers and safety of life and property from danger of explosion of steam-boilers. Replaces the Boilers Act, 1923.
The Oilfields (Regulation and Development) Amendment Bill, 2024	Amends the Oilfields (Regulation and Development) Act, 1948. Expands the definition of mineral oils, introduces petroleum leases, and decriminalises some offences.
*The Finance Bill, 2025	Gives effect to tax proposals of the central government 2025-26
*The Appropriation Bill, 2025	Authorises additional expenditure from the Consolidated Fund of India for 2021-22.
*The Appropriation (No 2) Bill, 2025	Authorises additional expenditure from the Consolidated Fund of India for 2024-25.
*The Appropriation (No 3) Bill, 2025	Authorises additional expenditure from the Consolidated Fund of India for 2025-26.
*The Manipur Appropriation Bill, 2025	Authorises additional expenditure from the Consolidated Fund of Manipur for 2024-25.
*The Manipur Appropriation (Vote on Account) Bill, 2025	Authorises expenditure from the Consolidated Fund of Manipur for 2025-26.

The Income Tax Bill, 2025	Replaces Income Tax Act, 1961. Retains most of its provisions, including tax rates and offences. Defines virtual digital spaces and adds virtual digital assets to definition of undisclosed income.	13 Feb 2025 Lok Sabha	Referred to Lok Sabha Select Committee
